Contributing to AGEST is easy...

Employers who have previously contributed to AGEST can continue using their existing payment methods.

Employers that have not previously contributed to AGEST can:

- > call **1300 724 378** for a copy of our Product Disclosure Statement, which contains the relevant form.

Contributions can be made either via direct debit, BPAY, EFT or cheque. Contribution details can be reported to AGEST online, electronically or on paper. Please call us on **1300 724 378** if you would like to discuss your options.

AGEST is a regulated superannuation fund within the meaning of the *Superannuation Industry (Supervision) Act 1993* ('SIS Act').

AGEST is a complying superannuation fund within the meaning of the SIS Act, and has never received a notice of non-compliance from the Australian Prudential Regulation Authority ('APRA').

AGEST is able to accept superannuation contributions (including employer, salary sacrifice, personal after-tax, rollovers, and spouse contributions) for eligible persons. These contributions are maintained and subsequently paid only in accordance with the Superannuation Industry (Supervision) Regulations.

If you're working and eligible for Choice of super fund, you can ask your employer to contribute to AGEST for you. Any employer (private or public sector) can contribute to AGEST for its employees.

Choosing AGEST is easy. Simply complete this form and hand it to your employer. It will give them all the information they need.

Even if you aren't eligible for Choice, now might be a good time to put your own money into AGEST. You can do this by contributing directly to AGEST from your own savings, or via a payroll deduction on either a pre-tax or post-tax basis.

It may also be a good time to think about bringing all of your super together. To do this, all you need to do is complete AGEST's *Transfer your super* form (call us for a copy or you can download it from our website). Once you have completed that form, send it to your old fund so they can transfer your account to AGEST.
